#### Funding announced for Salem Project

Outgoing Pictou West MLA Karla MacFarlane had some good news for the residents of Salem, Pictou County on her last day as their representative Friday, April 12.

She was joined at the West River Fire Hall by Premier Tim Houston who announced that the province will be contributing \$1.6 million to extend wastewater to the community of Salem.

The Salem wastewater extension project, which will cost an estimated \$3.2 million, will include the construction of a wastewater collection and pumping system to serve about 30 homes and businesses.

Funding for the project is part of the Municipal Capital Growth Program that was announced in February 2023. The project is expected to be cost-shared with the Municipality of Pictou County. MOPC Warden Robert Parker said the MOPC also hopes to apply for federal funding for the project.

The project is expected to improve the quality of life for current residents and create the opportunity for more growth in the region.

"Today's investment will ensure the residents and businesses of Salem have access to an upgraded wastewater system so

they can continue to grow and thrive," said Premier Houston.

Warden Parker shared similar thoughts with those gathered.

"In a lot of our villages and communities, housing happens when you have the things people are looking for," Warden Parker said. "You have to have decent water. You have to have sewer that works."

Warden Parker said a good deal of credit is also due the late Carl McCunn, who right up until his deathbed was actively lobbying for the project.

"Nobody worked harder than Carl to get this done," Warden Parker said. "For a fellow who knew he was on the way out, he was still very concerned about the sewer in Salem."

### How to pay your taxes



You can pay your property tax or water bills online through your bank by following these instructions:

#### **Property Taxes**

Go to "Add Payee" Search "Pictou" Select "Pictou County Taxes" Add all 8 digits of your Municipal Account number

#### **Water Utility**

Go to "Add Payee"
Search "Pictou"
Select "Pictou County Water"
Add all 8 digits of your Municipal Account number

# LANDFILL VOUCHERS AVAILABLE MAY 1

Landfill Vouchers from the MOPC are available from May 1st to Nov. 30th.

We are happy to mail them out to you or you can stop by our Administration Office at 46 Municipal Drive in Pictou between 8:30 a.m. and 4:30 a.m. Monday to Friday.

Vouchers are given free of charge to people who own homes or cottages in rural Pictou County. Vacant landowners, wood lot owners, etc, do not qualify for such vouchers. Each voucher will cover the tipping fee for up to 250 kg of garbage at the Mount William Transfer Station. They can be used individually or in combination for a maximum total of 1,000 kg



#### Always Check Before You Burn

From now until October 15, the provincial government will update its burn map at 2 p.m. daily at www.novascotia.ca/burnsafe or you can call for updates at 1-855-564-2876(BURN).



In counties coloured green on the burnsafe map (designated "burn"), domestic brush burning is permitted between 2pm and 8am.



In counties coloured yellow on the burnsafe map (designated as "restricted") domestic brush burning is permitted ONLY between 7pm and 8am.



In counties coloured red on the burnsafe map (designated "no burn") open fires are not permitted.

#### Do you need a permit to burn?

**For Domestic burning** of piles smaller than 2m by 3m and campfires, No, but you now need to check the burn restrictions map or phone line to see when you are allowed to burn.

For Industrial burning – YES – you do still require to obtain a permit if you are burning piles larger than 2m by 3m and will have more than 4 piles burning at once and are clearing land for building a structure, for agriculture or for blueberry burning over 2 hectares. Go to your local Natural Resources Office to obtain a permit.

#### Can I have an open fire in the morning?

No. No matter what colour the map shows, there is NO domestic brush burning or campfires permitted in Nova Scotia between 8am and 2pm, except Industrial Permits. For INDUSTRIAL PERMITS you must call the local office first prior to igniting your fire to make sure conditions are safe to do so.

#### What is domestic brush burning?

Domestic brush burning is burning (for no remuneration) woody debris in 2 piles or fewer which are no wider than 3 m and no taller than 2 m. Domestic brush burning includes campfires (except in licensed private, municipal, and provincial campgrounds) and blueberry burning which is less/equal to 2 ha.

#### What is considered a campfire?

Any open fire that burns no larger than 0.5 m in diameter and is intended for recreation and not for survival is considered a campfire.

#### What about burning in chimineas, fire pits, and other backyard burning appliances?

If the fire is not in an enclosed CSA approved appliance, the fire is considered to be an open fire. A chiminea is an open fire.

#### Some municipal bylaws vary from provincial rules - which do we follow?

Check and follow your municipal bylaws first. Your municipality may have a burning restriction that supersedes the provincial restriction. Municipal restrictions may include: the time burning is permitted, the type of burning appliance that is permitted, the location in the municipality where burning is allowed or not, etc.
