## **PRAYER**

Deputy Warden Thompson opened the meeting with a prayer.

## MEDIA RELEASE - GOVERNANCE ANNOUNCEMENT (MOU)

Deputy Warden Thompson read a statement to Council as follows:

"Since our last Council meeting, there has been a considerable amount of discussion on the topic of governance in Pictou County and around the Province of Nova Scotia. Recent announcements that Springhill and Bridgetown will file for dissolution are signs of a crisis that exists in Nova Scotia's local government.

Council wants to assure our residents and taxpayers that the County of Pictou is not in crisis mode. The Municipality is the largest of the six municipal units in Pictou County both in terms of population and tax base. Our municipality continues to experience new growth in our tax base.

This Council has and will continue to develop policies and procedures that provide for strong fiscal management, cost effective delivery of services and growth opportunities within the municipality.

We are committed to looking beyond our municipal boundaries; we will continue to support regional initiatives and are committed to regional progress within Pictou County and beyond.

On March 25, 2014, the Honourable Mark Furey, Minister of Service Nova Scotia and Municipal Relations met with all of the municipal units to inform us of the government's response to the Terms of Reference for the long discussed Governance Study. That decision has been well publicized; however, it

is important to note that Minister's Furey's decision was based upon his conclusion that the municipalities of Pictou County do not have a common vision or shared commitment to the content of the study.

The Municipal Council understands the position of the Minister; however, we are disappointed that the study will not proceed, as we believe it would have provided valuable information to our citizens. The Municipality of the County of Pictou was one of the first municipalities to endorse having a governance and organizational study undertaken.

On March 28, 2014, Mayor Barrie MacMillan of the Town of New Glasgow provided the Town's opinion and vision for the future of Pictou County Governance. Mayor MacMillan stated "Our next step and the new way of doing things is this: we are going to enter into discussions with the Municipality of the County of Pictou and the Town of Pictou to develop a Memorandum of Understanding on the things we agree are critical to our respective municipalities – be they tax rates, service levels or otherwise."

The County of Pictou has not signed a Memorandum of Understanding and welcomes the discussions that we will have with the Towns of New Glasgow and Pictou. The Municipal Council believes however, that it is critical that all municipal units begin a dialogue to advance a regional vision. To that end, the Towns of Trenton, Stellarton and Westville should be prepared to enter these discussions.

These discussions will require frank and open dialogue and a commitment to change the way we do things. Municipal government has evolved and we will continue to adapt, and continue to change. We encourage and welcome open dialogue regarding a regional commitment. This is a time for leadership, a proactive approach and action.

Minister Furey when he met with this Council said that the expertise and knowledge for change is in this room. The discussions that will take place over the next several months will be driven by this Council. The Municipality of Pictou County has been good neighbours with the five towns. We believe in a cooperative approach to local government in Pictou County. Our Warden and Council have taken this cooperative approach on a number of initiatives.

Each Municipal Councillor has been elected to represent our constituents, and it is a responsibility that we take very seriously. This Council will lay out its plan and strategies that will lead to meaningful change in this county. This Council wants to make it perfectly clear to all of our taxpayers, citizens and municipal units of Pictou County that terms of any Memorandum of Understanding will be on negotiated on our terms. They will reflect our values; protect the interest of the municipal taxpayers, and assets that support the municipality and the region."

Clr. D. Parker pointed out that the biggest problem with the golf course in Pictou is the location because it has more value for building lots. The cost to purchase the 9 hole golf course is quite high and to bring it back to its former state would be quite significant.

#### PROPERTY SERVICES COMMITTEE REPORT

Clr. D. Parker presented the report of the Property Services Committee as follows:

## PROPERTY SERVICES COMMITTEE REPORT

For information purposes the Property Services Committee submits the following report on the activities of the Committee for the month of March:

- Met with a proponent of a wind development project and residents of the Tower Road in Millsville to hear information on the construction of a wind turbine in the area by the developer and the concerns of the residents with regard to the set-back requirements in the Municipality's Land-Use By-Law. The Planning Advisory Committee has been asked to undertake a review of the LUB to determine the adequacy of the 600m setback which residents believe should be increased to 1.5 km.
- 2. Reviewed the report of the Building Inspector, By-Law/Dog Control Officer and Warden for the month of February.
- 3. Discussed information from Transportation & Infrastructure Renewal estimating the cost of installing LED lights at the underpass of Highway 104 at Exit 23 and agreed to consider this information further during budget deliberations.
- 4 Considered an application for the installation of an intersection street light in District #5. (Resolution to follow)
- 5. Received correspondence from a non-profit organization expressing interest in acquiring a former school property owned by the Municipality. The title of the property in question is currently under legal review for an opinion on marketability.

- 6. Approved the installation of a street light in District 2 in front of civic address #18 on the Point 44 Road in Little Harbour.
- 7. Requested that the Director of Public Works & Development prepare a listing of sewer and/or water project anticipated for installation over the next 5 10 years, along with information on how the projects will be financed.
- 8. Agreed to send a letter of support the Minister of Defense, the MP for Central Nova, the Chief of Defense Staff and the local MLA's in support of 144 Construction Engineering Flight and asking that there be no further cutbacks to the Flight's operating budget.
- 9. Agreed to recommend to Council the approval of additional funds to complete the engineering design for the McLellan's Brook/Upper Plymouth Wastewater Collection Project. (Resolution to follow)
- 10. Authorized the purchase of new GPS equipment from Cansel Survey Equipment Inc. to replace aging technology which will be given a trade-in value towards the purchase costs.

#### **MOTION**

Clr. Turple referred to Item #1 and reported that he met and talked briefly with some of the residents who attended the Property Services meeting. Their argument was that coal fired generators will continue to be in operation even when the wind turbines are at full capacity. Clr. Turple pointed out that we have to look into the future for our grandchildren and their children hoping to eliminate coal fired generators. He expressed his opinion that wind turbines should have a set-back distance of 1 km. from residences.

Clr. R. Parker reported that the residents would like to know when the Planning Advisory Committee will be having its second meeting on the set-back distances of wind turbines, adding that he has been advised by the CAO that the residents will have an opportunity to present to this Committee.

The CAO reported that work is currently underway to compile information requested by the Committee and once that is complete a meeting will be scheduled, possibly later this month.

Clr. Johnston reported that he was of the understanding that 2 public meeting will be held and the CAO responded that will occur once a decision is made by the Planning Advisory Committee.

Clr. Palmer pointed out there will only be a public consultation process if a change is made to the by-law.

# MOTION - PICTOU CO. CHAMBER OF COMMERCE

It was moved by Clr. L. Fraser and seconded by Clr. Palmer that Council approve a \$1,000 Council Grant to the Pictou County Chamber of Commerce for sponsorship of the annual Business Achievement Awards, and a second Municipal Grant to the Chamber in the amount of \$1,000 to assist with the preparation of a video promoting Pictou County exports.

Clr. R. Parker advised that he had difficulty supporting sponsorship for the Business Achievement Awards as he felt that a \$1,000 cash award to a large company was a waste of resources. He

recommended that the \$1,000 be earmarked for the promotion of entrepreneurship in the name of the company being recognized for their business efforts.

Deputy Warden Thompson reported that it was his understanding that this was a sponsorship and a way for the Chamber of Commerce to generate operating revenue that would cover a variety of expenses, including the Business Achievement Awards event.

Clr. R. Parker pointed out the information from the Financial Services Committee stated the money was to be used to purchase a trophy and he would like some clarification on where the money was to be used.

## SALVATION ARMY RED SHIELD CAMPAIGN

Deputy Warden Thompson informed Council the Salvation Army's Red Shield Campaign will soon be underway again this year and they will be hosting a dinner on Tuesday, May 13, 2014 at the Pictou Lodge. A table for 6 has been reserved for the Municipality at a cost of \$20 per person.

#### MOTION

It was moved by Clr. R. Parker and seconded by Clr. L. Fraser that Council purchase a table for 6 for the Salvation Army's Red Shield Campaign at a total cost of \$120.

Motion carried.

## TOWN OF NEW GLASGOW ANNOUNCEMENT

Clr. R. Parker referred to the recent announcement by the Town of New Glasgow on the development of an MOU between the Town, the Municipality, and the Town of Pictou, stating that he has never been as disappointed as a County Councillor hearing about the announcement from the Town of New Glasgow. He emphasized that this Council has to look out for the taxpayers of the Municipality by leading the way and determine what changes are to be made. He cautioned that Council has to be mindful of our tax rate, the debt in infrastructure that the towns have, and the services for the residents of the Municipality. These are very difficult issues that will require serious discussions. The residents of rural Pictou County should not be expected to shoulder the debt to help out the other units. The decisions have to be made by the elected people and if other people want to make the decisions then they should run for office. The worst thing we can do in the county is have a group of people making decisions for the future of the county that are un-elected. Clr. R. Parker read an article in the newspaper from the Minister of Service Nova Scotia & Municipal Relations as follows:

"My message to our Municipal leaders has been clear and consistent. We will not impose amalgamation on our towns and counties. The people of Nova Scotia expect leadership from the Councillors and Mayors they have democratically elected. I firmly believe that Municipal leaders possess the wisdom to make the right choices and the strength to make the tough call. They need no force or coercion from the Provincial Government."

- Clr. R. Parker reported that the Municipality needs to be perfectly clear that amalgamation does not fix everything.
- Clr. L. Fraser pointed out since Cape Breton amalgamated it has taken a tremendous amount of money to keep it afloat and that scares the residents of Pictou County. If Pictou County was to amalgamate it should be done fairly based on services and if not the residents who do not have any services will end up paying for the people who have services.

Deputy Warden Thompson reported that there were a lot of questions that needed answers which could have come from the study that will not take place and now the units will have to do the work themselves.

- Clr. D. Parker commented that the Municipality has almost half the population in the County and speaks strongly with a clear voice and there is strong leadership on Council. The time-lines advanced on March 28<sup>th</sup> by the Mayor of New Glasgow were not realistic and there are some significant issues that will take some real time. He pointed out that we are permitted to have 3 tax rates for residents, rural, suburban and urban but we are only permitted to have 1 commercial tax rate. Unless there are real savings to be had then why would we amalgamate and most of those savings would come from job losses with the administration and elected officials.
- Clr. R. Parker stated that the public needs to know that the Municipality is going to lead this process with elected people. If we manage to save money by amalgamation then we would be the first to do so as prior amalgamations have been proven to cost money.

## **ROAD CLOSURE - MACPHERSON TRAILER SALES**

Clr. L. Fraser reported that he received a telephone call from MacPherson Trailer Sales regarding the road closure. This problem started about 3 years ago when the trucks could get in and out but they need to have sand to do their sand blasting. He informed Council that he was speaking with Mr. Troy Webb who indicated that the road may be up-graded and reported that he will continue working with Mr. Webb on this process but he may need Council's assistance in the future.

## **UP-DATE - RIVERTON WIND TURBINES**

Clr. Dewar asked if there was an up-date on the Riverton Wind Turbines because the project does not seem to be moving forward.

The CAO reported that the contractor is waiting for NSP to do the inter-connection and that would complete Phase 1. The turbines have arrived for Phase 2 so at this point they are targeting mid-May to have the first 3 spinning and the second group of turbines should be spinning 2 weeks later.

Clr. Dewar asked how far behind are the projects and the CAO replied it is about a year behind schedule for Phase 1 but ahead of schedule for Phase 2.

#### **CLOSED SESSION**

Council met in closed session at 8:05 p.m. to discuss matters relating to contract negotiations.

### **OPEN SESSION**

Council resumed in open session at 8:20 p.m.

### **MOTION - FIREMEN'S ACCIDENT INSURANCE**

It was moved by Clr. L. Fraser and seconded by Clr. Davidson that Council approve the proposal submitted by JH Fraser for the Firemen's Life & Accident Insurance Program at a cost of \$27,500.00.
