BY APPOINTMENT

Jenna MacLeod, Clean N.S. Home Warming Program

CALL TO ORDER

Warden Baillie called the meeting to order and requested that Councillors stand and take a moment in silence to pray or simply reflect, as may be their preference, to help Council focus and properly do the work of the County.

AGENDA

It was moved by Clr. Palmer and seconded by Clr. S. Fraser that the agenda be approved with the addition of a closed session to discuss matters relating to legal advice eligible for solicitor-client privilege. Motion carried.

CORRESPONDENCE

Correspondence was received and acknowledged from the following:

a) Middle River Presbyterian Church (uncirculated) – thanking Council for the donation in memory of the late James Jardine, a former employee of the Municipality.

Clr. D. Parker spoke briefly on the late James Jardine who was a long-time employee of the County and a constituent of his district. He advised Council that Jimmie was the second person in Nova Scotia to receive a kidney transplant, a very quick-witted, kind and generous person and a long-time volunteer. Jimmy had the unique ability to express his opinions without ever offending anybody and shared that dry Jardine sense of humor. He was a major thread in the community and a volunteer with many groups and will be sorely missed.

Clr. Dewar reported that at last month's Council meeting he informed Council there were 12 homes in Lorne that had their heat pumps destroyed as a result of a power outage. Council sent a letter to Nova Scotia Power Inc. asking that the company reimburse these homes for the loss of their heat pumps. NSP has sent a letter to the homeowners apologizing for the inconvenience but advising that the company was not prepared to consider their claims. Clr. Dewar informed Council that he received correspondence from gentleman in Ontario who is trying to sell a surge protector that fits on your electrical panel. Clr. Dewar reported if this gentleman is ever in the area he would like him to come and speak to Council on this issue.

COMMUNITY ANNOUNCEMENTS

Clr. S. Fraser informed Council that Lismore's Dinner Theatre Winter Time Review will be held on March 4th, 5th and 6th, and stated that she has tickets available for anyone interesting in attending.

Clr. Wadden reported that the Little Harbor area lost power on Friday evening around 6:00 p.m. and many homes have alarms, especially residents that are away for the winter. So when the alarms go off it is triggered by the power going off and no fire department would ignore such an alarm. At 5:30 a.m. Saturday morning the Little Harbor Fire Department had such an alarm and they did respond. On behalf of herself as Councillor for this area she would like to say thank you to the Little Harbor Fire Department for once again showing they are there when needed and to other departments who answered similar calls or actual emergencies. The Little Harbor Fire Department set up a warming station for the residents to get a cup of coffee or whatever they required during the power outages. Their dedication does not go unnoticed and we are very appreciative for all they do. She also wanted to thank the crews from NSP who, although it is their job to restore the power, did work very hard to achieve the restoration as quickly as possible.

CLEAN N.S. HOME WARMING PROGRAM

Ms. Jenna MacLeod met with Council on behalf of the Clean Nova Scotia Home Warming Program. In addition to the information that had previously been distributed to Councillors, she circulated a brochure an application form to Council members. She informed Council that the Clean N.S. Foundation is an environmental group based in Dartmouth. This program is collaboration with Efficiency N.S. with funding provided by NSP and the Provincial Government. Home warming is a program that offers no-cost home energy assessments and free energy efficiency upgrades to homeowners living on a low income across the province. It is an extension of a program that has been around for a few years so this is a new format where the vision is moving forward. The prelude program started in 2006 and since that time it has evolved so this year there is a co-ownership with Clean Foundation and Efficiency N.S. This was done because NSP shareholders came forward and wanted to make a donation to do up-grades to homes across the province. Upgrades to homes that use electric heat are funded through that donation from NSP and managed by the Clean NS Foundation. If you heat with non-electric heat sources then all your upgrades are funded by the province and managed by Efficiency NS. In 2011 there were approximately 600 people assisted through the program; this past calendar year saw over 1,900 people go through the program. If someone is eligible for a program they find out which heat source they have and put them in the appropriate program. Representatives go to the home and do a home energy assessment to see how energy efficient the home is to start. They talk to the home owner about the up-grades that make the most sense and they find the contractor to do the work and they pay for it. The same person who did the assessment manages the up-grades so the homeowner has that one-on-one contact the whole time. At the end of the up-grades if anything substantial has been done we will go back to make sure the work has been done to the quality and standard they want so that the homeowner does not have any other questions. To be eligible for the program you have to own your home and it has to be a year-round residence. It has to be a single family dwelling and there cannot be any rental units within that space. The program is offered to income-qualified homeowners and they look at the before tax income amount on the Notice of Assessment to verify income. For 1 person living in a home the total income has to be less than \$20,952; for 2 to 4 people living in a home the total income has to be less than \$20,952; for 2 to 4 people living in a home the total income has to be less than \$55,444. All applications are handled by Efficiency NS and there are other programs that homeowner may be eligible for as well. On the application and brochure there is a toll-free phone number and e-mail address to contact Efficiency NS and the Clean NS Foundation. Ms. MacLeod informed Council that 50% of the participants in this program are seniors.

Clr. S. Fraser commented that there are a number of low-income residents in the Municipality who currently receive a municipally-funded tax exemption and suggested that they may be a target group for this type of program.

Ms. MacLeod advised that they are piloting a couple of programs like that but right now Housing Nova Scotia has a couple of home repair programs that you can apply for that has very similar eligibility criteria. We have an agreement with Housing Nova Scotia where someone applies to their programs they can sign a consent form to pass their name along so they do not have to fill out an application and that way they just get funneled into the program. We are piloting that process with Shelburne at this time and we are looking for other areas in the province that want to participate in this process as well. They are also looking to have a separate consent form that describes the program attached to whatever application people are filling out and the other is an after-the-fact consent so if the Municipality was interested she encouraged a follow up with her to see if something can be done this year or next year.

Clr. R. Parker asked if someone who has already had an energy assessment done by Efficiency Nova Scotia and received funding would be eligible for this program.

Ms. MacLeod replied that Efficiency Nova Scotia has a secondary program called the "Home Energy Assessment" where people pay a fee to get their assessment done and if they do the recommended up-grades they get rebates back. If someone has gone through the previous version of this program and did not pay for their assessment and up-grades, it has not changed enough to make them eligible at this point.

Clr. D. Parker reported that he has never heard of the Clean Nova Scotia Foundation before and Ms. MacLeod pointed out that it used to be called Clean Nova Scotia that was really involved in waste disposal. She explained that the Clean Foundation has been working as a contractor for Efficiency Nova Scotia for the past 7 years.

Clr. D. Parker asked where the budget comes from and Ms. MacLeod explained that it is all donations from NSP shareholders as well as government funding and other donations.

Clr. D. Parker asked if there is a maximum amount spent on a home and Ms. MacLeod replied that they have a sliding scale budget.

Clr. D. Parker reported that one of the criticisms he heard when Efficiency Nova Scotia ran the program was that 1 company was getting all the work and so he asked if this organization obtains competitive bids.

Ms. MacLeod replied that this is one area where the electric and non-electric programs do differ so for the non-electric program Efficiency Nova Scotia gives the entire file to a contractor who has a lot of work done by Trinity Solutions. The electric program has a set group of contractors they work with and anyone can get added to that list but they have to meet their quality and safety guidelines.

Clr. D. Parker asked if NSP has contributed a fixed amount and Ms. MacLeod replied it is a \$37 million contribution over 10 years. At present the non-electric funding is secured for 3 years and they have approximately \$12 million they are working with every year.

Deputy Warden Thompson pointed out that there has been a big push for homecare in Nova Scotia but one of the weakest points is that many of the seniors are freezing during the winter months. If there was some way to get this information out to seniors it would be very helpful and beneficial to them. In Pictou County we have the Pictou County Fuel Fund that people use when needed so you may be able to tap into this information.

Clr. L. Fraser asked where the offices are located and Ms. MacLeod replied that there are offices in Dartmouth and Cape Breton with satellite stations through the province. Ms. MacLeod informed Council that she would be the best contact for any questions about the application process.

Warden Baillie thanked Ms. MacLeod for the presentation and excused her from the balance of the meeting. (7:40 p.m.)

The LED street lights conversion continues, primarily in the western portion of the County. As work concludes in Pictou and Trenton crews will be re-deployed to the Municipality.
- 3. Reviewed correspondence from the Department of Environment outlining amendments to the Municipality's current operating approval for the Hopewell/Eureka Sewage Treatment Plant which will require the Municipality to work towards adherence to the Atlantic Canada Wastewater Guidelines Manual for Collection, Treatment & Disposal by January 1, 2020, as well as adding an expiry date of December 15, 2025 to the approval.

A couple of reoccurring themes at the January 19th meeting were:

<u>BE IT RESOLVED</u> by the Municipal Council for the Municipality of the County of Pictou that Council adopt the following policy with respect to Tax Exemption & Tax Reduction:



POLICY # 2016-02-12

MUNICIPALITY OF THE COUNTY OF PICTOU TAX EXEMPTION & TAX REDUCTION POLICY

- 1. This Policy shall be known as the Tax Exemption & Tax Reduction Policy.
- 2. This Policy shall apply to the properties listed in Schedules "A" and "B" and "C" commencing April 1, 2016.
- 3. Pursuant to section 71(1) of the *Municipal Government Act*, the properties listed in Schedule "A" to this Policy shall be, subject to sections 4 and 9 of this Policy, exempt from real property taxation.
- 4. The tax exemption provided in section 3 shall apply to general tax only and shall only apply to the portion of the property specified in Schedule "A".
- 5. Pursuant to section 71(2) of the *Municipal Government Act*, the real property tax payable with respect to the properties listed in Schedule "B" to this Policy shall be, subject to sections 6 and 9 of this Policy, reduced to the tax that would otherwise be payable if the property were residential property, inclusive of area rates.
- 6. The tax reduction provided in Section 5 shall apply only to that portion of the property specified in Schedule "B".
- 7. Pursuant to section 71(1) of the *Municipal Government Act,* the properties listed in Schedule "C" to this Policy shall be, subject to sections 8 and 9 of this Policy, exempt from real property taxation.
- 8. The tax exemption provided in section 7 shall only apply to general taxes and shall only apply to the portion of the property specified in Schedule "C", exclusive of sewer user charges and fire rates.
- 9. When a property listed in Schedule "A", "B", or "C" ceases to be owned or occupied by the owner indicated in the schedule, or if the property ceases to be occupied for the purpose, which pursuant to section 71(1) and 71(2) of the *Municipal Government Act* enabled the Municipality of the County of Pictou to include the property in this Policy, the tax exemption or reduction shall cease and the owner(s) of the property shall immediately be liable for the normal real property tax on such property for the portion of the taxation year then unexpired.

EMERGENCY RESOLUTIONS – ELECTRICAL OUTAGES

Clr. R. Parker reported that he was speaking with a very upset constituent about the power outages during the recent storm and asked that a letter be sent to the UARB on this issue.

AGREED

It was agreed that Council send a letter to the UARB regarding the recent power outages.

Clr. R. Parker informed Council that not everyone has power as yet and the concern raised was if there was more work done trimming the trees in the summer we would not have this problem now. The more trees that are caught up in the lines that have not been trimmed for 20 years the more likely you are to have a problem.

MOTION

It was moved by Clr. R. Parker and seconded by Clr. Turple that Council send a letter to the UARB asking that they examine the practices of NSP regarding tree trimming during the summer months and if there is any incentive/penalty for NSP if a person's power is not restored within a certain time period.

Clr. Wadden pointed out that there are other issues besides tree trimming that may have to be looked at as well.

Clr. Turple reported that there are trees growing up on both sides of the lines on many of the back roads and they should have been trimmed years ago.

Deputy Warden Thompson reported that when he called the outage line there were major outages all over Pictou County.

Clr. D. Parker informed Council if you do not do some preventative maintenance on equipment then it will let you down when the weather is bad. There needs to be an incentive that after a certain number of hours those people who suffered that inconvenience should receive free power for that billing period. This has been going on since at least White Juan which was 12½ years ago and there does not seem to be any improvement. NSP still has the most incompetent public relations for dealing with power outages of any business he knows.

Clr. L. Fraser reported if the weather did not turn mild we still would not have any power because the trees were hanging over the power lines like a jungle. There should be an incentive put in place so NSP will do more when the weather is better.

Motion carried.

PRESENTION - INFORMATION ON BEHALF OF ALLAN ENGLISH

Clr. Turple informed Council that he is in contact with Mr. Allan English who lives in Braeshore and he was asked by Mr. English to make a presentation on his behalf as follows:

"I am Allan English and my wife and I own a business and have a home in Braeshore. I would like to thank Municipal Council for allowing me to share my information and I thank Clr. Turple for presenting it. This will take up to 6 minutes of your time and the rest is up to you. Transparency is a catch word of the 21st century. It is used by many seeking elected office and it insinuates that when elected taxpayers will see exactly what their level of government is doing with their tax dollars in a way that the average citizen would understand. For instance, the Town of Pictou's budget uses colored pie charts that are very easy to comprehend but not so much with the Municipality's budget. The single largest item in the proposed 2015/16 Municipal budget of \$16,690,732 is education at \$4,491,723. I wondered how many Councillors were aware of just exactly what the educational item was for or even about until Clr. Turple brought it up during a Council meeting last fall. In my earlier conversations with Clr. Turple he admitted he was unaware that the item was a provincial property tax imposed on property owners of the Department of Education and if so he agreed that perhaps it should not be included in the expenditures portion of the budget. I regret not giving him all the ammunition he needed to make the point more important. Here is how the Department of Education defines the mandatory education tax in an informal letter from June 2004. I guote, "the bulk of School Board funding comes from 2 sources, the Provincial Government and contributions from property taxpayers mandated by the Education Act. The latter amount is determined by the province which sets a property tax rate known as the Mandatory Education Tax Rate (MET). All property owners in Nova Scotia pay the same rate currently .3510 per 100. The municipalities collect this property tax on behalf of the Province and remit the revenue to the School Boards. Although this tax is called a minimum Municipal contribution it is not a tax on municipalities. It is a property tax especially targeted to education collected by the municipalities because they already collect a property tax. The Province could collect this tax directly but that would create unnecessary duplication. The valuation of properties for this purpose known as uniform assessment is conducted by Service Nova Scotia & Municipal Relations." For those of you who do not know what uniform assessment means here it is described by Municipal Affairs? Final uniform assessment is used to determine the mandatory educational tax rate as well as other provincial property taxes and is based on the total provincial CAP residential and commercial tax base. Again I quote, "One measure of a municipality's financial health is its own source revenues based as represented by the total uniform assessment. This figure is the total of the tax property assessment plus the value of grants received by special property tax arrangements." In the Municipality of Pictou County the Provincial property tax rate is based on the 2015 final uniform assessment amount of \$1.473.479.664. It is my understanding there are 3 more provincial property taxes in the expenditures column of the budget and they are the Nova Scotia Correctional Service Tax of \$310,195, the Nova Scotia Housing Deficit Tax of \$105,000 and the Nova Scotia Regional Library Tax of \$171,137. This gives us a total of all 4 provincial taxes collected and submitted to the Regional School Board and the Province of \$5,078,055. If you want to include the VPSC assessment charges of \$492,543 that brings the grand total to \$5,570,698. If all that I say is true then I suggest to Council that in the spirit of transparency the total of +/- \$5,570,698 be removed from the

expenditures column of the 2016/17 budget. Divided accordingly and shown separating on the semi-annual property tax bills with a property explanation. If the Province could collect these taxes directly it becomes obvious that they do not belong in the expenditures column of any municipal budget in Nova Scotia. Heaven forbid there would be any unnecessary duplication. Taxpayers would no longer be charged a municipal tax on top of a provincial tax and disgruntled property owners can be directed to speak to their MLAs. A note of interest, the HRM Provincial property tax bill is not included in the expenditures column. Their rural residential tax rate for last year was .636 per \$100 and the rural commercial rate was \$2.56. Council then has the task of adjusting the 2016/17 and beyond expenditures budgets downward by +/- 35% and ultimately the property tax rates to the level where owning a residential or commercial property in the Municipality of Pictou County for total tax purposes would eventually be neutral. I would like to ask the Solicitor if any interpretation of the Provincial property taxes as pointed out by the Education Act and Assessment Act are factual and this Council may indeed do as I have suggested should they wish. I believe the property tax payers of Pictou County would more easily understand and appreciate this type of transparency. I recommend that Council accomplish this task agree or not as soon as possible so it does not get lost in the congestion of amalgamation should the County residents vote in favor."

Clr. R. Parker asked if there was any tax that we are charging on top of a provincial tax and the CAO replied the Municipality's tax rate includes an amount to cover the education, correction and housing so we are not taxing on top of a tax.

Clr. Turple asked if this may be looked at in future so we can provide better transparency to the residents.

Warden Baillie replied all units seem to be moving in that direction so he does not see any reason why we would not do the same.

<u>BE IT RESOLVED</u> by the Municipal Council for the Municipality of the County of Pictou that Council adopt the following by-law with respect to spring road weight restrictions:



MUNICIPALITY OF THE COUNTY OF PICTOU SPRING ROAD WEIGHT RESTRICTION BY-LAW

1. This by-law may be cited as the "Spring Road Weight Restriction By-law".

2. In this by-law:

- a. "gross vehicle weight" means the sum of the individual axle weights of all axles of the vehicle or combination of vehicles;
- b. "Municipality" means the Municipality of the County of Pictou;
- c. "Restricted Road" means a highway or road in the Municipality which is listed at Schedule "A";
- d. "single axle" means an axle that transfers the load carried by it approximately equally to the wheel or wheels attached to each end of the axle;
- e. "Spring Weight Restriction Period" means
 - i. the same period in a given year over which, pursuant to subsection 20(1) of the *Public Highways Act*, R.S.N.S. 1989, c. 371, as amended, the applicable Minister for the Province of Nova Scotia, or designate, prescribes that public highways or public roads, including bridges thereon, will be subject to closure or restrictions to traffic or to any class or classes of traffic, or
 - ii. such other period as the Municipality, at its discretion, may determine by resolution and announce by way of notice published in a newspaper circulating within the Municipality at least two weeks before such period is to begin in a given year;
- f. "tandem axle" means an axle assembly containing 2 consecutive axles whose centres are at least 1.20 m apart and no greater than 1.85 m apart
 - i. attached to the vehicle in such a manner that the load on the axle group is equalized on the 2 axles, and
 - ii. equipped with brakes on both axles;
- g. "triple axle" means an axle assembly of 3 consecutive axles with the centres of no 2 consecutive axles less than 1.20 m apart, and
 - i. attached to the vehicle in such a manner that the load on the axle group is equalized on 3 axles, and
 - ii. equipped with brakes on all 3 axles;
- h. "tridem axle" means an axle group of 3 consecutive, equally spaced axles within a vehicle that does not include any liftable or self-steering axles and that has the same number and size of tires on each axle, with a minimum outside axle spacing from 2.40 m to a maximum of 3.70 m;
- i. "tridem equivalent axle" means an axle group that is made up of 3 consecutive, equally spaced axles within a vehicle and that has all lift axles lowered and the same number and size, and that has the same number and size of tires on each axle, with a minimum outside axle spacing from 2.40 m to a maximum of 3.70 m; and
- j. "vehicle" means a vehicle as defined under the Motor Vehicle Act, R.S.N.S. 1989, c.

293, as amended;

- 3. No vehicle may be operated on a Restricted Road during a Spring Weight Restriction Period, except as permitted under this by-law.
- 4. Vehicles under the following applicable maximum vehicle and axle weights may be operated on a Restricted Road during a Spring Weight Restriction Period:
 - a. maximum single axle weight of 6,500 kg, except single-drive school and passenger buses, public utility service trucks and fire-fighting trucks;
 - b. maximum tandem or triple axle weight of 12,000 kg per axle grouping;
 - c. maximum tridem or tridem equivalent axle weight of 18 000 kg per axle grouping; and
 - d. maximum gross vehicle weight of 12,000 kg for single-drive school and passenger buses, public utility service trucks and fire-fighting trucks that exceed 6500 kg on a single axle.
- 5. The following vehicles may also be operated on a Restricted Road during a Spring Weight Restriction Period:
 - a. public utility service trucks while responding to emergency situations, including the restoration of services or the establishment of new services to occupied buildings;
 - b. fire-fighting trucks while responding to emergency situations, including attending actual fires, medical crises and motor vehicle accidents, and assisting in fire investigations;
 - c. trucks hauling bulk milk and solid waste (garbage haulers) are permitted to haul 80% of normal axle loads, steering axles are permitted to carry registered weight to a maximum of 6,500 kg, provided the carrier holds a special permit issued by the Province of Nova Scotia and allowing such operations, as provided for under the *Spring Weight Restriction Regulations* under the *Public Highways Act*, R.S.N.S. 1989, c. 371, as amended; and
 - d. vehicles which the Municipality owns, operates or has hired others to operate for the Municipality or public utility vehicles while such vehicles are engaged in maintenance and repair work on municipal roads or streets or utility appurtenances included therein, or to police or fire service or emergency service vehicles or equipment engaged in the line of duty.
- 6. Every person who violates or fails to comply with any of the provisions of this by-law shall be guilty of an offence and, upon summary conviction, liable to pay a fine and penalty of not less than One Hundred Dollars (\$100.00) and not more than Ten Thousand Dollars (\$10,000.00) and, in default of payment, to imprisonment for a term not exceeding sixty (60) days.
- 7. The offences, fines and penalties or rights of restitution provided for in this by-law, are intended to be in addition to any other applicable offences, fines or penalties or rights, including rights of the Municipality to recover for property damage by way of civil action.
- 8. When a person causes damage to a Restricted Road through conduct in violation of this by-law and is convicted of an offence as a result, in addition to and without limiting any other relief which might otherwise be available to the Municipality and in addition to any fine or penalty which might be imposed, a Court may also order that such person pay restitution to the Municipality in respect of all such damage.

MOTION - AMENDMENT

It was moved by Clr. R. Parker and seconded by Clr. Turple that the Spring Road Weight Restrictions By-Law be amended to delete clause 5 d.

Clr. Wadden asked if restrictions like that could result in operators deciding not to deliver to a road and the Solicitor responded that the by-law, with the amendment, effectively mirrors the provincial restrictions so that is something we are not going to run into.

Clr. R. Parker reported that he was talking to one of the oil delivery companies and they do this all the time on the provincial roads so they are quite aware of the process.

Clr. Dewar asked who is going to police this and Warden Baillie replied that it would fall under the jurisdiction of the By-Law Enforcement Officer.

Clr. Dewar asked if that service could be contracted out because the Municipality does not have the proper equipment to police the roads.

Warden Baillie pointed out that it is more for the trucks who do damage to the road.

Clr. Wadden asked how often has damage been caused to a municipally-owned road and the CAO confirmed that last year was the first time.

Clr. R. Parker pointed out this by-law is mostly a preventative measure and once these trucks know the roads are closed we should not run into the same problem as last spring.

Motion carried.

MOU UPDATES & QUESTIONS

Clr. D. Parker asked for an outline on what the process is between now and May 28th and Warden Baillie replied that there will be a joint meeting of all 4 Councils in closed session on Wednesday evening to review the final submission to the NSUARB. On Thursday evening each Council will meet individually in closed session to determine if the pre-conditions have been met. Councils will then go into open session to make a motion to accept the package and move onto the plebiscite. The UARB will hold hearings at the Holiday Inn and the Scotsburn Fire Hall from March 7th to 11th and then public presentations will be held on the information that is to be passed by Council.

Clr. D. Parker asked the reason for the UARB hearings and the CAO explained that the UARB will review the merits of the evidence filed, following which the Board will release a preliminary decision in April based on that evidence.

Clr. D. Parker asked if Council intends to hold more public information meetings in the districts and Warden Baillie replied that the Steering Committee will be holding public meetings.

Clr. R. Parker reported that people are confused that the UARB is ruling on this before the public has given their decision at the plebiscite at the end of May. If the UARB makes a decision in April there will be a perception by the public that we are already applying for amalgamation.

Warden Baillie pointed out that the UARB will not make a final decision until the end of June, based on the plebiscite and the votes of the individual Councils.

The CAO commented that in all likelihood the UARB is going to say in April that the evident which has been submitted meets the fact based-information supplied to the Board.

Clr. Dewar commented that there are letters in the newspaper every day on this application and expressed his opinion that the UARB's ruling should come after the plebiscite. There are so many grey areas in this process and now there are advertisements in the newspaper about the dates of the UARB hearings. Clr. Dewar pointed out that nothing should be said until after the plebiscite.

Warden Baillie pointed out the UARB is issuing a report on the evidence it received and individual Councils have until June 20th to decide if they wish to withdraw from the application.

Clr. Dewar reported that he does not understand why the UARB is so involved in this process and Warden Baillie replied that the Board is the jurisdictional body in this matter.

Clr. Dewar asked the cost for the plebiscite and Warden Baillie replied that the cost will be the same as other elections.

NEWS STORY - GREENHILL SPRING

Clr. D. Parker referred to the newspaper story that mentioned several springs in the County and he appreciates the fact that the DOE tries to warn us of potential hazards. There are dozens of people who depend on the Greenhill spring for their daily supply of drinking water and it appears there is fear mongering that the water is not safe. Clr. D. Parker stated that coliforms are a type of bacteria so you cannot find any stream or brook that does not have some coliforms in it. In his opinion he would never hesitate to drink from any of these springs because they are good, cold, clean water but we are fairly adapted to handle a few coliforms in our water and we do not have to give into this kind of fear.
