MUNICIPAL ALCOHOL PROJECT

Clr. Wadden reported a few highlights as follows:

Our Committee certainly appreciates the continued support from all our respective Councils especially the Letters of Concern re the Liquor Control Act amendments. We have no updated information as to where that stands.

We have a Bridging the Gap Facebook page resulting from our Inter-generational event held earlier this year and it seems to be working out well keeping in touch with the interested youth from this function with the possibility of coming up with other ideas for future workshops.

We are currently in the process of applying for a Chronic Disease Innovation Grant with the hope of planning some type of Northern Zone Intergenerational Function. Our Committee has actually been the group who developed the Model for the Intergenerational Forum and have been recognized across the province for our lead on this role.

In closing, we are in the process of acknowledging our appreciation to our respective councils which you will likely receive before our October Council meeting, but I would like to serve notice here that this is a very active and focused committee strongly supported by our Councils. We are very proud of the fact that we maintained our Vision and our Mission throughout our past few years of this committee's lifespan. We know elections are coming up in October and each of us want you to know how important it will be to continue councils' strong participation and representation on this committee. Some of the players may change, but we hope the MAP committee will continue with good representation and with strong municipal support.

I think one of our strong points has been that we do not come to councils looking for funding for our projects but work very hard applying for grants through various avenues, primarily provincial, for the funding we require to bring our projects to the forefront and so far that has worked guite well for us.

Other than that, I think our minutes are pretty self-explanatory as to where our committee is right now.

ECONOMIC DEVELOPMENT WORKING GROUP

Clr. R. Parker reported that the group met twice and once with our MP, Sean Fraser to bring him up-to-date on what the group has been doing. He is an important player to have on side as we look at different strategies in order to improve the employment in this County. Any money that was being invested in Atlantic Canada would go towards the Atlantic Growth Strategy. The 5 items that fit under that strategy are immigration, infrastructure, tourism, trade & innovation and climate change. If we had any jobs related to those particular fields we would have a better chance of getting funding at the Federal level. He was very interested in becoming an ex-officio member of the Working Group and that was granted to him. The Working Group met last week with the 20/20 group and discussed economic growth and how to better our communities. Once the 20/20 group were excused there was discussion on the development of a Request for Proposals (RFP) for an Economic development Plan. Clr. R. Parker informed Council that he met with the CAO this morning about an RFP and the representatives from each municipal unit are taking back to their Councils to ask for approval of an RFP to do an economic study. The CAO had informed him that it will take several weeks to get the RFP ready and approved. They are looking for a plan that will allow them to work on the different economic pillars.

CONGRATULATORY LETTER – TOWN OF NEW GLASGOW

Clr. Palmer reported the Town of New Glasgow made a major announcement several weeks ago about Web.com coming to Pictou County and they are going to create upwards of 360 jobs. He wanted to congratulate the Town of New Glasgow for bringing that company to Pictou County for the jobs that are desperately needed.

MOTION

It was moved by Clr. Palmer and seconded by Clr. Turple that Council send a letter to the Town of New Glasgow congratulating the Town on the hard work in bringing Web.com to Pictou County with the help of Career Connections, Nova Scotia Business Inc., and Crombie Reit.

Clr. D. Parker noted these may not be ideal jobs but they are paying more than minimum wage.

Motion carried.

WATER QUALITY ISSUES IN LITTLE HARBOUR

CIr. Wadden reported that she had the opportunity to attend a very informative presentation put on by the Aquaculture Association of Nova Scotia and the Sea farmers Association about keeping the waters clean in Little Harbour. The presentation was done in a partnership with the Aquaculture Association, the NSCC and Paul Berdeski concerning the importance of oyster fishing to our economy. This group went back to 1954 gathering data and comparing it to what we are seeing today. The amount of development along the coastal areas in Pictou County has increased many times over. Other issues affecting our coast are failing septic systems, clear-cutting, agriculture, industry and the list goes on and on. The focus of last week's discussion was on the coliform levels being found in their test results. This type of pollution is from warm blooded mammals which would be animal or human such as deer, birds, and so on. When the coliform levels reach 43 shellfish fishing is shut down and does not reopen until the levels have gone back down. Since 2011 we have seen we have seen an increase in coliform levels in the results and some results were over 200. Several years ago Melmerby Beach was shut down due to the high coliform levels but they never did conclusively determine what caused the problem at Melmerby Beach but we know it never happened before and has not happened since. When the levels of coliform reach 43 the industry is

shut down but they are seeing readings as high as 200 in some of the inlets along our coast. They are sporadic but they are still reaching levels of 200 in some areas since 2011 but because they are not public swim areas the information goes to Halifax and stays there. She was able to find out the testing is done by the Federal Government's Department of Environment and Climate Change in Halifax. This is a serious concern all along the coast of Pictou County and not just District 2.

MOTION

It was moved by Clr. Wadden and seconded by Clr. S. Fraser that Tom Smith from Sea Farmers be invited to make a presentation to Council on the coliform levels in our coastal waters.

Motion carried.

WATERSHED MANAGEMENT

Clr. Wadden pointed that a few of the districts along our coast do have water and sewer and we depend on our wells as well as septic systems to maintain our water supply. This is one of the biggest issues we are facing today as a result of climate change and it is time that Council becomes more proactive on this issue. We have many issues in this county effecting our water supply but this is not about pointing fingers, it is about putting our heads together and coming up with a solution for the whole county. This is a project that we need to be at the table working on together. One of the suggestions received at a presentation last week was the initiation of a Watershed Committee for watershed management. She would also like to credit Steve Goodwin who was at the meeting who spoke specifically to the suggestion and it was he who asked the crowd there and it was supported. She has raised the concerns in her area regarding failing septic systems and their impact on the community. The distance and lack of population to bring this system to Little Harbour would be very expensive but there are other options available.

MOTION

It was moved by Clr. Wadden and seconded by Clr. Davidson that the Mayors and Warden Committee, in consultation with First Nations, be asked to consider the formation of a Watershed Management Committee.

Clr. R. Parker asked if the Municipality already had Councillors sitting on a Watershed Committee and the CAO replied all water utilities are required to have a Watershed Management Plan.

Clr. Turner pointed out the residents in Abercrombie are concerned about the leeching from the Landfill Site and he knows testing is done. He stated that he would like Earl Cameron to make a presentation to Council on the leeching because the residents are quite concerned. Clr. Turner reported that he would request on behalf of the residents that Earl Cameron give a report on the leeching and he would forward it to all the residents of District 9.

Clr. Wadden reported that it is important that the Municipality is involved with the towns as part of a Watershed Management Committee.

Clr. Johnson informed Council that both Deputy Warden Thompson and he are on the Forbes Lake Watershed Committee with the Town of New Glasgow and that Management Plan works very well.

Motion carried.

EMERGENCY RESOLUTION

There were no emergency resolutions.

REFERRALS TO COMMITTEES & NOTICES OF MOTION

Clr. Dewar asked that at a future Property Services Committee meeting that a letter be sent to the Departments of Transportation & Agriculture requesting they remove the weeds on the shoulders of paved and graveled roads.

- Clr. Davidson asked that the Linacy Fire Dept. Loan Guarantee be put on the agenda for the next Financial Services Committee meeting.
- Clr. L. Fraser reported that he heard that the government has been talking about shutting down the Riverview Home so he would like to add to this item to a future committee meeting.
- Clr. D. Parker informed Council that he sits on that Board and the current Minister has declared that all institutions will close, however there is no plan going forward as to how that would be affected. There are people living at the Adult Residential Center for all their adult life and they are not likely to be successful in a community setting. The Board members are concerned about the quality of life of the residents in that home.
- Clr. R. Parker reported that we have to be careful regarding the weeds in the fall because there are certain ones that are excellent feed for the bees.
- Clr. R. Parker asked that the Westville & Area Refugee Group's financial request be put on the next Financial Services Committee agenda.
- Clr. Turple gave notice to Council that he will not be reoffering in the October 15, 2016 Municipal Election.

ADJOURN

It was moved by Clr. Johnston and seconded by Clr. L. Fraser that the meeting adjourn. Motion carried. (8:00 p.m.)
