# FINANCIAL SERVICES COMMITTEE REPORT

For information purposes the Financial Services Committee submits the following report on the activities of the Committee for the month of June:

1. Met with representatives of residents on the Tower Road and surrounding area who are concerned with the proposed installation of 3 domestic wind turbines in the community. The residents have asked Council to increase the setback for multiple domestic wind turbines, to review the process of approval, and to halt the proposed development by Northumberland Wind Field Inc. Council has referred those requests to the Planning Advisory Committee for consideration and recommendation.

- 2. Met with representatives of the Hemlock Group who provided an overview of the group's proposal to revitalize Trenton Park. The project is projected to cost \$2,681,445 and municipalities are being asked to contribute \$150,000 based on population. The request to this Municipality is \$76,950 over 2 3 fiscal periods, together with a letter of support outlining that commitment which can be used to document local support to other levels of government who will be asked to make financial contributions, and to the corporate community during a fundraising campaign.
- 3. Reviewed the report of the Recreation Coordinator for the month of May.
- 4. Considered several requests for financial assistance. (Resolution to follow)
- 5. Reviewed applications from volunteers expressing interest to sit on the Municipality's Audit Committee and Ad Hoc Recreation Strategy Committee. (Resolution to follow)

# PROPERTY SERVICES COMMITTEE REPORT

For information purposes the Property Services Committee submits the following report on the activities of the Committee for the month of June:

- 1. Reviewed and discussed the reports of the Building Inspector, By-Law Enforcement/Dog Control Officer and Warden for the month of May.
- 2. Received an update on the status of capital projects. Construction on the McLellan's Brook/Upper Plymouth Wastewater Phase II Project continues to be on schedule for a mid-November completion. Preliminary design drawings for the Abercrombie Wastewater Extension Project have been reviewed and revisions requested. Staff is hopeful that this project can go to tender at the end of the June. Design drawings for the Springfield Estates Wastewater Extension Project are currently under review and the project is expected to go to tender in July. The construction tender for the Green Acres Road has been awarded and work will commence when all of the legal documentation is in place. Design on the 3 sidewalks is nearing completion and tenders could be back to the Committee at the July meeting. Hydrant flow testing is being carried out in Springfield Estates and cost estimates are being obtained to have similar testing carried out on all our systems over the next several months.

4. Agreed to reserve an easement in favor of the Municipality over the surplus properties in Lyon's Brook to address parking concerns at the school and then proceed with tenders advertising the 3 properties for sale.

# DANGEROUS & UNSIGHTLY PREMISES HEARING - JOHN JOSEPH MACLEAN (7:24 P.M.)

At 7:34 p.m. Warden R. Parker convened a hearing with respect to a dangerous and unsightly premises assessed to John Joseph MacLean, 3681 White Hill Road (AAN 05106567). Neither Mr. MacLean nor anyone else representing this property were present in the Chambers.

Council viewed an electronic presentation of pictures taken earlier today by the By-Law Enforcement Officer showing the property in question.

Ms. MacCarthy reported that this property was brought to her attention in June, 2016. A title search was requested in August of 2016. A signed complaint form was received on this property. The title search was received in December 2016 which was too late in the year to send notices to clean up or demolish the property. On June 14, 2017 the initial notice was send and it was returned that same day by Canada Post marked "unknown"; on June 21, 2017 the Notice of Opportunity to attend this Council meeting was posted on the property and mailed to all parties with an interest in the property. Some effort was spent to determine if, in fact, the property was foreclosed on by the bank. The property is 2.17 acres and the taxes were paid in full on June 7<sup>th</sup> of this year.

Clr. Turner asked for an outline of what is considered to be dangerous and unsightly on this property.

Ms. MacCarthy advised that the property is vacant, not in keeping with the properties that surround it, is able to be entered into by a passerby, vehicles, large tires on rims, grass, and is surrounded by wood lands that would be at risk in the event of a fire.

Ms. MacCarthy advised that one vehicle has gone missing since the first initial notice but outside of that nothing has changed on the property.

- Clr. D. Parker advised that this property was vacant for a number of years and then a squatter moved in and he and his family lived there for several years. They did not have electricity during their stay and the majority of the debris was left by the squatters when they vacated the premises about 13-14 months ago. There have been un-drivable vehicles taken in and out of there, a chest freezer, and the roof of the home leaks badly. In Clr. D. Parker's opinion the house was not repairable and not fit for habitation and those in the community would like to see the house removed so that someone else does not move into it. Clr. D. Parker confirmed that the property is not in keeping with others in the community.
  - Clr. Thompson asked that any wells on the property be secured to prevent any potential hazards.
- Clr. D. Parker advised that to the best of his knowledge there was no drilled well or septic system on the property.

# DANGEROUS & UNSIGHTLY PREMISES HEARING - WILLIAM NORMAN MUNROE

At 7:34 p.m. Warden R. Parker convened a hearing with respect to a dangerous and unsightly premises assessed to Willian Norman Munroe, 16 Maple Leaf Lane, Eden Lake. Neither Mr. Munroe nor anyone else representing the property were present in the Chambers.

Council viewed an electronic presentation of pictures taken earlier today by the By-Law Enforcement Officer showing the property in question.

Ms. MacCarthy reported receiving a signed complaint form in May, 2016. An initial notice for clean-up was sent on May 24, 2016; some initial clean-up took place where a lot of debris was removed, however the cinderblock basement/crawl space has remained (although it was part of what was requested to be cleaned up). On September 21, 2016 a final notice was sent for the property owner to address concerns and no further compliance was forthcoming. A second complaint form was received on December 19, 2016 and a title search was requested on April 25, 2017 and received on April 26, 2017. Notice of Opportunity to attend Council was posted on June 21, 2017. The property is 0.4 acres and taxes were paid in full on June 15, 2017. The shed on the property is structurally sound and not part of the Draft Order.

With respect to the shed, Clr. Thompson agreed that it is structurally sound, however neighbours are concerned that there is a door missing which could grant access to children playing in the area. Overall, the property is not in keeping with other homes in the area with significantly high assessments.

Discussion ensued around the requirement for a door on the shed and the solicitor advised that Council can include the requirement for a door in the scope of the Demolition Order, or it could be done at the Administrator level. He also advised that there could be a requirement for the door to be completed earlier than the 30 days given for the other items in the Demolition Order.

"We have not had a meeting since our last Council meeting on June 12. Our next MAP meeting is scheduled for next Thursday, July 13. As I advised last month, we plan to work on some type of forum to educate councillors on the legalization of cannabis which is scheduled for July 2018. Our intention is to assist Councillors to understand the many implications from this legislation which can and will impact municipalities. Our MAP Committee would most likely focus on the harms of excessive use of cannabis to our society but there are many legal and social aspects which Councillors should be aware off.

I have been speaking with our Warden, Deputy Warden and CAO to get their perspective on what they would like to see at this forum. The same is true for all Councillors here. I encourage you to talk with me and help me make suggestions which will make this forum valuable for you as councillors to attend. I have spoken to Lyle Goldberg at our UNSM office; he advised me a UNSM - AMA working group on Cannabis Legalization has been approved by the UNSM Board. This group will also include reps from policing. Also, Jack MacPherson, a councillor from Antigonish, is working to help his council become more aware of this situation. He advised me the NS Association of Police Governance Fall Conference is scheduled for Pictou Lodge Sept 27th to the 29th and one of the topics being covered is the legalization of marijuana implementation plans. Hopefully our Police Advisory Committee are aware of this conference. So as you can see this is becoming a very important issue and people are realizing we must all be well educated on the facts.

As plans for our forum progress I will be updating you."

# **RESOLUTION – INTERSECTION ST. LIGHTS**

Clr. MacKeil presented a resolution to Council as follows:

## RESOLUTION

<u>WHEREAS</u> the Municipal Council for the Municipality of the County of Pictou has adopted a policy with respect to the provision of street lighting at intersections in areas where residential street lighting does not exist;

<u>WHEREAS</u> this policy is intended to aid in the safe passage of motor vehicles on public streets or roads and pedestrian traffic at street intersections and other pedestrian infrastructure in a manner which is both affordable and adequate for vehicular and pedestrian traffic;

# **GROUP MAILBOX @ SINCLAIR RD. – CHANCE HARBOUR**

Clr. Wadden reported receiving numerous complaints concerning the placement of a new group mail box on the Sinclair Road. Some of the concerns were not being able to get off the road with this being just before a curve on a very twisted road, poor visibility from the main intersection with Highway 348 which will be made even more treacherous with snow banks in the winter time. The ditch runs on both sides of the box. The Chance Harbour Wharf is on this road and the car and truck traffic is very high during the various fishing seasons and with recreational uses going on, as well as this being a very busy cottage area. Chris Mannett of Canada Post (Halifax) advised that he too has received many complaints about this box and had recommended to his supervisor that the box be pushed back to allow a space for cars to pull off safely. That was not done and Mr. Mannett was going to make a second request to his supervisor. Mr. Mannett did confirm that the box was approved by TIR and did meet Canada Post requirements. Unfortunately the supervisor has advised Mr. Mannett that since the box does meet Canada Post guidelines, nothing would be done for the residents. TIR has advised based on the 50 km speed zone, the Department's measurements, and the results of a 2010 traffic study the Department supported the location of the box. Previously there were two group boxes on this road that didn't meet the new requirements, even though they were there for many years and residents could pull off the main road. Mr. Mannett advises that if the matter was to be escalated any further it would have to be done through Canada Post in Ottawa.

#### MOTION

Butler that a letter be send to Canada Post outlining the concerns with the new group mailbox on the Sinclair Road and advise Canada Post that the residents believe there is a better solution than doing nothing, by either pushing the box back to allow drivers to get safely off the road, or move the group box to the same site where the Lewis Road residents pick up their mail on Highway 348, with copies of the letter to be sent to Chris Mannett and James Bugbee of Canada Post, Sean Fraser, Basil Pitts at TIR and Tim Houston.
