Clr. D. Parker brought the following resolution to Council:

RESOLUTION

<u>BE IT RESOLVED</u> by the Municipal Council for the Municipality of the County of Pictou that Council adopt the following policy with respect to low income tax exemption:

POLICY #2023-02-06



MUNICIPALITY OF THE COUNTY OF PICTOU LOW INCOME TAX EXEMPTION POLICY

In accordance with the provisions of Section 69 of the Municipal Government Act, being Chapter 18 of the Statutes of Nova Scotia, 1998, the Municipal Council for the Municipality of the County of Pictou hereby enacts the following policy with respect to low income tax exemption:

1. In this policy "income" shall be as defined in Section 69 (1) of the Municipal Government Act and means a person's total income from all sources for the calendar year preceding the fiscal year of the Municipality, and includes the income of all other members of the same family residing in the same household, but does not include an allowance paid pursuant to the *War Veterans Allowance Act* (Canada) or pension paid pursuant to the *Pension Act* (Canada).

- 2. An exemption from taxation in an amount not exceeding \$250.00 shall be granted for a person assessed with respect to taxable property in the Municipality of the County of Pictou who is a resident of the Municipality, and whose income from all sources for the year preceding the year for which the exemption is sought is less than \$30,000.00.
- 3. The exemption extends only to the property occupied by the applicant as his/her principal residence.
- 4. A person applying for an exemption shall make an affidavit confirming the person's income.
- 5. The deadline for filing an application for a low income tax exemption shall be March 31st annually.

REPEAL

All former policies with respect to low income tax exemptions are hereby repealed.

MOTION - RED CROSS GIFT CARDS

Clr. Boyles said the distribution of Red Cross cards used as financial relief after Hurricane Fiona is not being done fairly. He said people are not getting enough information about why they are being denied funding despite meeting the criteria.

It was moved by CIr. Boyles and seconded by CIr. MacKeil to send a letter to federal government leaders and Central Nova MP Sean Fraser to find out the criteria for the financial assistance and if people can appeal if they are denied assistance. The motion was amended to include sending a copy of the letter to the Red Cross.

NSP TREE CLEARING REGULATIONS

Deputy Warden Murray_said that Nova Scotia Power wants to cut trees back further from poles and lines than they are allowed now, but_they don't have the easements from the property owners. NSP wants a list of the roads in rural Pictou County that should be trimmed.

Deputy Warden Murray recommended that a letter be sent to the Nova Scotia Government asking that easements by the province be extended so that Nova Scotia Power can do a better job of clearing trees from power lines, thus preventing future damage.

Clr. Palmer said for NSP to have the easements extended, it would need to expropriate land from residents. He said similar procedures are followed when the Department of Transportation changes roadways. It is a large and costly process.

Clr. Wadden said she would want more information and requested NSP come to chambers to answer questions about this and other issues, such as debris cleanup from Hurricane Fiona.

Warden Parker said a meeting with NSP did take place, and the issue of cleaning up debris from Hurricane Fiona was addressed. He said it was suggested that Council send a list to NSP with areas of concern. He said NSP could come to a future meeting so Deputy Warden and Clr. Wadden's concerns are addressed in person.

Clr. MacKeil said she understands Deputy Warden Murray's concerns but feels other issues must be addressed first, including fixing damaged powerlines by Hurricane Fiona.

Clr. Dewar said he is concerned about the number of people who need NSP to hook up their power and have to long for this service.

Deputy Warden Murray said he would wait for NSP to come to Council Chambers to answer questions, so he withdrew his motion to send a letter.

RESOLUTION - BASIC LIVABLE INCOME

Coun. Thompson brought the following resolution to Council.

RESOLUTION

<u>WHEREAS</u> the growing social crisis and impacts of poverty have downstream effects on our municipality, putting unsustainable pressure on our limited resources to

deliver necessary public services and social infrastructure supports as we struggle to keep up with the evolving needs of our community.

WHEREAS Basic Income addresses key social determinants of health, such as income and housing, it can alleviate pressures on municipalities to address poverty and fill gaps in social supports, such as shelter, housing, food security and mental health. Research and pilots show that when people have a sufficient and secure income their mental and physical health improves; they have the capacity to secure more affordable, suitable, and safe housing, childcare, healthy food, and transportation; and poverty rates decrease.

WHEREAS the provision of a guaranteed livable basic income would benefit individuals, families and communities and protect the most vulnerable in society, it would also support community resilience by facilitating the transition to a local economy that responds to the climate crisis and other major challenges. Evidence shows that a federally funded basic income that improves people's financial stability is possible, as successful income transfer programs already exist in Canada for seniors (Old Age Security and the Guaranteed Income Supplement) and for parents (Canada Child Benefit (CCB)

THEREFORE, BE IT RESOLVED that the Council of the Municipality of Pictou County directs that a letter be written to the Prime Minister and Premier of Nova Scotia calling on these orders of government to work towards implementing a Guaranteed Livable Basic Income to eradicate poverty and homelessness and ensure everyone has sufficient income to meet their basic needs.

Warden Parker said Council had a good presentation on this topic and the letter calls for the federal government to begin working on the plan.

Clr. Elliiott said she is struggling with this concept because she is unsure how the federal government will decide who will get the money and how they will tell people they are not supporting it. She said she would not be supporting the motion.

Clr. Butler said it is more effective to target people most in need through programming already in place rather than everyone. He said he would not be supporting the motion.

Clr. Turner said he supports the motion because this will change the economy for the better, and concerns about employment needs to be focused on the employer. He said wealth stays at the top, and there are too many people suffering from poverty and food insecurity, and we have to find ways to raise them up, and a guaranteed basic income will do this.

Clr. D. Parker said it would relieve some of the worst poverty that exists. He said some programming, such as child and senior benefits, helps, but more needs to be done. He said Council has to ask if it wants to help those most in need in our society. He said this is about dignity and sharing our humanity. This is not a huge shift; it is not an economic question but a moral one. He said all that is being discussed is the principle of the matter.

Clr. MacKeil said she feels the system is not working and needs a complete overhaul. This should be done before introducing another program. She said she was bothered by the term "meaningless jobs" used during the presentation. She said those jobs are part of our society's function and are important. She said the working class is struggling now, and extra money coming into everyone would be helpful, but there is no such thing as free money with the government.

Clr. Wadden said a program like this has great potential and this resolution tells the government we want to see this move forward.

Clr. Boyles said he does not have enough information to support the motion.

Clr. Dewar said all Council is doing is sending a letter, but it could make a big difference in helping move this along and helping others in this country. He said if it ever happened, he would like to be able to say he helped someone who needed it.

Clr. Palmer said he sees no harm in sending a letter, but it is the federal government's decision and will determine to fund other programs. He said he agreed the system put in place is not working, but he saw during COVID that people who received CERB assistance stayed home and never returned to the workforce.

Warden Parker said Council only sends a letter, and someone else has to work out the details. On the subject of meaningless jobs, he said workforces are having trouble filling positions, but people don't want to do certain jobs anymore. He said he worked long, hard hours as a youth picking potatoes, but that work ethic is not with us anymore. He said we need to pull some people up, and they will look at the world in a more positive way. The idea of looking at a different way of doing something is a good idea.

Clr. Thompson said it is important to raise people up, and they will do better for themselves and their community. He said if someone wants to aspire to be better, they have to go into a deep debt; this is a way to even it out and lifts people up. He said

current programs do not do that, particularly the welfare program that takes back money if someone wants to work while collecting welfare. He said this program is not universal and reaches the lowest income people. In our County, he said one of the growth industries now is food banks, the usage of food banks, their expansion, and relocation of them. He said he wants to eliminate food banks and a program like this has that ability.

Clr. Wadden reminded Council she is looking for information about establishments that sell alcohol in their communities. It is being collected for research for the Municipal Alcohol Project.

Clr. Boyles said there would be a dance at the Hillside Community Hall on Feb. 11, and its Friday Night Jam session will also take place on Feb. 10th.

Warden Parker said he attended a meeting at the Durham Community Hall about the wireless internet project. More meetings are planned, including the River John Legion on Feb. 9 and the Hillside Community Hall on March 2.

Warden Parker congratulated Sueann Musick for accepting the Director of Corporate Services/Deputy Clerk position for the Municipality of Pictou County.
