CAPITAL PLANNING

CAO Cullen said that the results of the Capital Planning Survey have been completed. Eight projects received majority support. Mr. Cullen went through the list of the survey results and explained the projects that were viewed as priorities or those that were to be deferred for future consideration.

CAO Cullen said the results from this survey will be brought to another meeting, and a financing plan will be built on how these projects will be prioritized and to build a financing plan on how they will be completed.

Clr. Thompson asked about the Blue Acres Sidewalk because it was not listed on the survey. CAO Cullen said that was already on the list from last year.

Clr. Wadden expressed disappointment with the Little Harbour Sidewalk and there has to be a way of dealing with some of the smaller projects because the larger projects will always overpower them.

Warden Parker said there is a safety issue, but the Department of Transportation must be part of the solution, which would be the first step. Clr. Wadden said that has been put forward to the Department of Transportation, and they are hoping to hear positive results. However, this still won't solve the issue of smaller projects being overshadowed.

Warden Parker said that a letter was received from Divert NS. The warden read the letter to the Council saying that Divert NS will pay 75% in advance for the 2024 diversion credits and map allocation. A diversion credit of \$401,348.00 is a result of the current year's advance of 358,000 plus the 2023 adjustment of \$43,348.00. The Map allocation of \$62,888.00 is a result of the current year's advance of \$56,900.00 plus the 2023 adjustment of \$5,988.00. The Warden said considerable money goes to the landfill part of Shared Services to help with education and modernization of whatever the funds are needed for. If it weren't for that, the municipality cost would be more, so the tax rate would have to go up.

CONSIDERATION OF DEFERRED BUSINESS
