





Staff Recommendation on Recreational Grant Funding

The Municipality of Pictou County has budgeted **\$7,000.00** in its Community Recreation Program Operating Grant for 2025/2026. This grant covers several sources of funding for recreational programming including Community Recreation Programming, Leadership Programming, Operating Assistance Grants and Start Up Grants:

The Community Recreation Program Grant which allows the municipality to grant up to \$750 to a community organization that is offering summer recreation programming to MOPC residents. There are four districts that offer such programming so if all the funds are requested this amount would come to \$3,000.00.

We currently have grant requests from the following organizations. To ensure the requests do not exceed the budget, staff have made the following recommendations:

Operating Assistance Grants:

UC Friends (Thorburn Youth Group) - \$1,000.00 Lismore and District Recreation (Youth Leadership Program) - \$1,000.00 Little Harbour Youth LEAD Arts Program - \$1,000.00

Start Up Grants

Pictou County Music and Memories Café - \$200.00 - Programming Keltic Chorus Women's Choir - \$200.00 - Programming Pictou County Arm Wrestling Association - \$200.00 - Programming

LACK OF GRASS CUTTING ON SHOULDERS OF THE ROAD

Clr. MacKeil noted that last year, there were a lot of areas within the county where the shoulders of the roads had not been mowed until September. Clr. MacKeil stated that in a rural municipality this is a safety issue with wildlife. Clr. MacKeil was happy to report that since the request was made to have this discussion added, some efforts have been made in District 3.

Turner to send a letter to the provincial government and local MLAs to thank them for the work that has already been done but to remind them that this is a safety issue for residents and to ask that the grass cutting and tree trimming along the roads be done in a timely manner. **Motion Carried**

Nay Votes: Clr. Andy Thompson Clr. Randy Palmer Clr. Debbie Wadden

Clr. Palmer made a phone call to find out how many mowers are available to do this work and was told there was one in the east and one in the west of the county. Clr. Palmer stated that there are a lot of roads within Pictou County and only two machines are available to do the work. Clr. Palmer will not support the motion. Clr. Wadden noted

that this is a huge concern but is uncertain as to what would be achieved by sending a letter.

Clr. Thompson stated being unable to support the motion to write a letter to the provincial government. Clr. Thompson agreed that there is a lot of overgrowth, but unless the municipality is prepared to spend money, then it should not be complaining to the province. Clr. Thompson noted that approximately a year ago the province wanted to hand over secondary roads and the municipality said that it did not want to manage the roads.

Clr. MacKeil stated that residents' concerns of public safety are the concern of Council and that the local MLAs do take notice of these letters. Clr. MacKeil said that this is a timing issue but the request to send a letter is to look out for the residents and public safety concerns. Clr. Parker agreed that this is an ongoing problem and is supportive of sending a letter.

CAPITAL IMPROVEMENT PLAN

CAO Cullen noted that none of the eight projects met the 50% plus one threshold. The CAO said that the Capital Improvement Plan would be the projects that have already been on the plan for the previous years.

Councillors discussed the procedure for prioritizing the projects on the Capital Plan.

Clr. Turner stated that it is striking that there is no plan for years 3, 4 and 5 and that it is the responsibility of this Council to change the way that things are evaluated and put on the Capital Plan. Clr. Turner said that it is disappointing to Councillors who had worthwhile projects and that it should be reconsidered to how Council put capital projects together. Clr. Turner noted that hard data is needed to make proper decisions.

Clr. Baillie said that it is difficult to move projects forward if they do not make the list and that ¾ of the projects from year one will move on to year two.

Clr. Parker expressed that it is critical for residents to have water and will continue to fight for this for the residents of District 7.
