1. I/We am/are a person(s) assessed with respect to taxable property in the Municipality of the County of Pictou.

That I/we understand the word “income” shall be as defined in Section 69(1) of the Municipal Government Act and means a person’s total income from all sources for the calendar year preceding the fiscal year of the Municipality, **and includes the income of all other members of the same family residing in the same household**, but does not include an allowance paid pursuant to the *War Veterans Allowance Act (Canada)* or pension paid pursuant to the *Pension Act (Canada)*.
4. That I/we understand the exemption extends only to the property occupied by me as my principal residence and the maximum exemption from taxation will not exceed **TWO HUNDRED FIFTY dollars (\$250.00)**.
5. Total income from all sources for the year **2022** was less than **THIRTY THOUSAND DOLLARS (\$30,000.00)** and was made up as follows:
