A message from the Warden

Hello to all residents of our rural municipality.

What a year 2023 has turned out to be and we still have one quarter to go. Across our province we have experienced terrible wildfires, tragic floods and now another hurricane. Thankfully, Hurricane Lee was a kitten compared to last year's lion Hurricane Fiona.

As our climate continues to change, we are almost guaranteed that climate disasters will get more frequent and more intense. Therefore, we need to be more prepared.

Our local government has an outside consultant looking at municipal infrastructure to see where the weak points are that might not hold up under even worse storms. Particularly vulnerable are our water and sewer systems as we saw in Fiona. Many couldn't handle the deluge of water or the lack of power.

We also need to be prepared to help all our residents when the next natural disaster hits. One of the big efforts we have embarked on is having many more and better equipped comfort centres across our rural communities.

The Province and Municipality have both contributed funding for new generators throughout the county.

These generators are often quite expensive as they involve upgrading outdated electrical systems at the same time. With

the ability to keep our comfort centres warm and lighted, the other big requirement is volunteers to operate them.

We know that our communities want to assist their neighbours in time of need.

We need to encourage them to be organized and ready with teams and lots of supplies. If a Fiona type storm comes in the middle of winter, the need for well supplied comfort centres could be much greater.

Another key factor that became abundantly clear during Fiona was the importance of communication with each other and emergency services.

Our council is pushing NSPC to do better and 'strengthen the grid.' We are hoping and encouraging some of the cell phone providers will use our wireless towers to improve their service for cellphones in Pictou County.

We certainly can't control the weather but we can learn from the past to be better prepared for future events. Please make your own preparations for future weather emergencies as one thing is for sure, they are coming. Please stay safe and watch out for your neighbours and friends.

MOPC FirstHome Internet progressing

This summer crews have been busy working to bring high speed, quality internet to residents of Pictou County.

While the projects have taken longer than initially anticipated, significant progress has been made in the last few months.

On the fibre side work has been focused in recent months on the Loch Broom Loop and up the Sunrise Trail. Service is now available to customers:

The fibre line between Pictou and Toney River is expected to be ready for connections by the end of October and between Toney River and River John by the end of the year.

Wireless update

On the wireless side, this summer has been spent getting towers ready to connect more customers to the MOPC First Home wireless network.

The River John, Hardwood Hill, Green Hill, McLellans Mtn and Eureka towers are fully online now and the rest of the towers in the network are expected to be completely online by the end of the year.

The remaining towers will become available in this order:

- MOPC Tower- Admin Building
- Willowdale
- Eden Lake
- Mount Thom
- Sunny Brae
- East River
- Meiklefield
- Poplar Hill
- Pictou Water Tower

Speeds start at 25 Mbps download and 5 Mbps upload. Your signal will be tested before the service is connected to ensure adequate signal strength. The service is \$49.99 a month plus tax. There is also a 50 Mbps download and 10 Mbps available for \$79.99.

Be prepared for emergencies

Fall and winter are fast approaching and with a change in the seasons, we see a change in the weather.

With any storm, whether it is a hurricane or a snowstorm, there are some key things that residents should keep in mind.

The main message we want to share is to prepare, not panic.

Residents are encouraged to have enough food and water to last for at least 72 hours ahead of any major storm.

In addition to food and water, residents should have first aid supplies, fuel in their vehicles and batteries for flashlights and radios. You should also make sure that any prescriptions you need are filled.

We don't want people driving around immediately after a storm because there could be hazards such as downed lines, trees on the road or flooding.

The 72-hour period allows time after a storm for response crews to get comfort centres up and running and ensure roads are safe before people start driving.

As soon as roads are safe after a storm, comfort centres will be announced in areas where they are needed.

Information about comfort centres is shared with local radio stations and will also be published on your local municipality's website and social media channels.

What's most important in communities like ours, though, is for people to look after each other, just like we saw in the aftermath of Fiona. We encourage residents to check up on their elderly neighbours in particular and to make sure their needs are being met.

Together we can weather the storms ahead.





Comfort centres added in District 7

The biggest news in our district is the creation of two "warming centres". Thanks to an 80 per cent grant from the Province of Nova Scotia, larger propane fueled generators have been installed at the West River Fire Hall and at the Union Center Community Hall.

These generators, which are sized to power the entire building, along with electrical upgrades are automatic. Hopefully they will permit operation of a "comfort" Center during extended power outages or other emergencies.

Civic numbers play an essential role in helping first responders find you in an emergency. We cannot stress how important it is that you and everyone in your home and workplace know your civic address and post it properly.

If I do not have civic number, how do I get one?

How do you purchase civic number signs?

Some local fire departments will order signs for residents. See the list of fire departments and businesses that provide that can provide signs.

Can I place my sign anywhere on my property?

About the Project

Imagine MOPC is a project to develop a Municipal Planning Strategy (MPS) and Land Use Bylaw (LUB) for the Municipality of Pictou County. Currently, there is no land use planning in MOPC, with the exception of the Wind Energy Bylaw and Subdivision Bylaw. In 2018, the Provincial Government passed new legislation that requires every municipality to adopt land use rules that meet newly established minimum planning standards. The Imagine MOPC project will bring the municipality into compliance with this provincial mandate.

What is Planning and Why Does it Matter?

Planning is the process by which communities can control change and development in their physical environment. Planning seeks to balance the needs of people, the economy and the environment by determining where, at what intensity, and in what form certain land uses should take place. It plays an important role in keeping populations safe and healthy, and allocates growth through proactive (or deliberate) transportation and infrastructure planning, making it easier and more efficient for people to get around.





Planning **helps us prepare for change.** This can be environmental change, like sea level rise, or social change, like an aging population.





Planning **supports our community's character and culture** by promoting good urban design, a quality public realm and by keeping development consistent and complementary.





Planning **protects special and sensitive environments** by preventing or limiting development in these areas.





Planning **helps to protect people** from developing in areas where the natural environment presents a high risk.





Planning **helps to maintain a healthy, sustainable economy** by ensuring there is a good balance and proximity between places of work and places to live.

Frequently Asked Questions

Now will the project affect me and my property?

The new planning documents, once adopted, will apply to anything you may want to build or develop on your property in the future. Existing land uses and associated structures (that were legally constructed) are protected under the *Municipal Government Act* as a "non conforming use" or "non conforming structure" and are not required to comply with the new LUB unless they are enlarged or the use is discontinued. Everything that exists legally remains the same!

- Will the introduction of zoning have any impact on my property taxes?

 No. Property taxes are calculated based on what's actually happening on the property, not by the zoning.
- Are these documents set in stone?

 Planning documents are dynamic and change over time to adapt to changing demographics and trends. Your elected municipal Council has the power to make changes to planning documents at any time.



Assistance can help offset home heating costs

Now that the outside temperature is starting to drop, energy cost savings are top of mind for many people. Did you know that Nova Scotia residents can apply to several rebate programs that could help reduce their energy costs this winter?

Home Warming – This program offers nocharge energy assessments and free home upgrades to eligible Nova Scotians. The plan is open to income-qualified homeowners. If the evaluation proves that draft-proofing, insulation, or other efficiency options can make a difference in heating or cooling your home, it will install the upgrades at no cost. Eligible participants must meet the total net income levels; you must own a single-unit home in Nova Scotia and provide proof of ownership, you must live in your home yearround with no plans to sell soon and your home must not have already been upgraded through Home Warming or the Low-Income Homeowner Service. The Heat Fund – Formerly known as The Good Neighbour Energy Fund is an emergency heating program available to Nova Scotian families. This program, administered by The Salvation Army, receives its funds from Nova Scotia Power Inc., NSP employees and customers, and the Nova Scotia Provincial Government. Applicants can re-apply every 24 months to the program, which runs annually from January through April. If you are in an emergency home heating situation, please download the application form or pick one up from your local Salvation Army church or thrift store, as well as MLA offices. Efficiency Nova Scotia has several rebate programs available. A home energy assessment is highly recommended to determine if rebates apply to insulation, heating pumps, wood/pellet burning equipment, solar equipment, and other upgrades. Pictou County Fuel Fund – This local program provides short-term assistance to people who don't have other options and face the prospects of an unheated home environment. MOPC launches green energy financing program

PICTOU – The Municipality of Pictou County is thrilled to announce the launch of Switch MOPC. This program was created with the goal of addressing the climate crisis, all while helping homeowners live more affordably and efficiently.

The municipality has partnered with SwitchPACE, a community interest corporation, who will help administrate and finance the program. Switch MOPC builds off the success of numerous other Switch programs that exist throughout the Maritimes. In Pictou County, the program will provide easy and financially viable opportunities for homeowners to make green energy upgrades to their properties.

The Switch MOPC program currently offers financing exclusively for solar projects.

Through Switch MOPC participants are offered fixed interest rates, with financing for up to 10 years with no upfront costs for installed equipment. Homeowners can finance up to \$40,000 or 15

percent of their property's assessed value. The municipality will pay the contractor, with the homeowner paying back the loan from energy savings.

The Switch MOPC program, also features a team of Energy Concierges who will guide homeowners through the entire upgrade process including home energy assessments, project and contractor selection, and access to generous rebates and incentives available through Provincial and Federal programs.

Warming Centre Committee established

Volunteers needed to ensure success

The generator has been installed and the new West River Fire Department Warming Centre is preparing to operate. The concept is to provide a gathering place during emergencies and during extended power outages.

At the Centre, as needed, people can gather to get warm, charge devices and have light refreshment (tea, coffee, soup, sandwiches).

The Chief of the Fire Department, in consultation with the Coordinating Committee, will declare when the Centre is open and when to close it. The Centre may be staffed around the clock depending on demand until the emergency is over.

To allow this to operate, we need volunteers. We require three types of volunteers:

- Staff to attend at the fire hall. We anticipate these volunteers will be scheduled in 4-hour or 8-hour shifts. Their tasks will include greeting and assisting their neighbours, preparing tea and coffee, etc.
- 2. "Home bodies" Those who have a home generator and are able to prepare soup and sandwiches.
- 3. Drivers Those with a larger, heavy 4WD vehicle capable of driving through heavy

snow. These drivers will check on their neighbours to determine if they need help, transport people and prepared food to the Warming Centre.

Be a responsible dog owner!

It has been a busy summer for the Municipality of Pictou County's Dog Bylaw Enforcement Officer.

During the month of July, the bylaw officer was called for nine incidents involving dogs. In three of those incidents someone was bitten, and, in another incident, chickens were killed.

That troubling trend has continued into August with several serious incidents reported in various parts of the county.

In light of these incidents and attacks, residents are reminded to keep their dogs on leashes when they are in a public area and not to allow their dogs to roam. If a dog is known to be aggressive, it should be kept muzzled when it's around other people and dogs.

The MOPC encourages all dog owners to register their dogs so they can be easily identified if they are found off their property.

MOPC Tags are \$10 for spayed and neutered dogs, and it is a lifetime tag. Non-spayed and non-neutered tags are \$35.00. You can purchase your dog tag(s) at the MOPC Administration Building at 46 Municipal Drive, Pictou, NS.

Fire Prevention Week 2023

The National Fire Protection Association® (NFPA®) — the official sponsor of Fire Prevention Week™ for more than 100 years —has announced "Cooking safety starts with YOU! Pay attention to fire prevention TM" as the theme for Fire Prevention Week, October 8-14, 2023.

This year's focus on cooking safety works to educate the public about simple but important steps they can take to help reduce the risk of fire when cooking at home, keeping themselves and those around them safe.

According to NFPA, cooking is the leading cause of home fires, with nearly half (49 percent) of all home fires involving cooking equipment; cooking is also the leading cause of home fire injuries. Unattended cooking is the leading cause of home cooking fires and related deaths.

In addition, NFPA data shows that cooking is the only major cause of fire that resulted in more fires and fire deaths in 2014-2018 than in 1980-1984.

"These numbers tell us that more public awareness is needed around when and where cooking hazards exist, along with ways to prevent them," said Lorraine Carli, vice president of the Outreach and Advocacy at NFPA.

Following are cooking safety messages that support this year's theme, "Cooking safety starts with YOU! Pay attention to fire prevention":

Always keep a close eye on what you're cooking. For foods with longer cook times, such as those that are simmering or baking, set a timer to help monitor them carefully.

Clear the cooking area of combustible items and



keep anything that can burn, such as dish towels, oven mitts, food packaging, and paper towels.

Turn pot handles toward the back of the stove. Keep a lid nearby when cooking. If a small grease fire starts, slide the lid over the pan and turn off the burner.

Create a "kid and pet free zone" of at least three feet (one meter) around the cooking area and anywhere else hot food or drink is prepared or carried.

"Staying in the kitchen, using a timer, and avoiding distractions that remove your focus from what's on the stove are among the key messages for this year's Fire Prevention Week campaign," said Carli.

We require volunteers for ALL positions, these include but are not limited to. Driver/Operators, Safety Officers. Accountability Officers, Traffic Control, and other supportive roles. There is no age limit for who can apply, and there is a job for all skill and comfort levels.
