NEW SCOTLAND BUSINESS PARK REPORT

The New Scotland Business Inc. Report for the month of April 2024 was received as presented.

RIVERVIEW HOME CORPORATION

Clr. Parker said that the Department of Community Services has been making rounds to the ARC and RRC's that offer services and support. There is a court order to close these institutions. The individuals who are currently residents will be housed in the community in groups of no more than four individuals. Notification was given last week that the closure date must be by November 2026. Clr. Parker said that this challenge is greater than it may appear, and there is a need to purchase or build 12-15 homes in Pictou County.

Clr. Parker said that each resident will get their own budget and can choose to live where they wish. After November, that building will have to be disposed of. Decisions will have to be made by the Council of the six municipalities. Clr. Parker said the clients will have support staff to guide them in decision-making. Provincial Government departments are interested in the existing facility. Clr. Parker said that every other province has moved individuals into the communities.

Clr. Wadden asked how this was working in the other provinces. Clr. Parker said that British Columbia is the longest operation and best model for this. This started in the 1970s or 80s in B.C. Collectively, they do seem to work, but there will always be challenges. Clr. Parker said that this will probably bring more job opportunities, and those with experience should have a leg up getting a new job in the system.

Clr. Parker said that locally, there is Highland Community Residential Services (HCRS), which has been following this model for decades. This model will have to be followed through the transition, and Councillors will do all they can to help with this process for the residents.

INTERNET SERVICE AND THE HILLSIDE HALL

Clr. Boyles said there is concern about Hillside residents being unable to access the internet. Clr. Boyles said that Council made it public that everyone in Pictou County would have internet but are now being told that it is unavailable in Hillside, and it seems Hillside is being pushed aside.

Warden Parker said the plan is to send a drone to investigate why there is no reception there.

Clr. MacKeil asked if Hillside is an area that can already get internet service from another provider and said that to receive the funding from the federal government, their guidelines had to be followed. Clr. Boyles did not know if the hall was in an already serviceable area. Clr. MacKeil stated that many residents in District 3 were not served.

Warden Parker said that the belief is that everybody will have access to this service, but to get the funds to complete the project, the federal government conditions had to be met, and unserved areas had to be completed first. Warden Parker said that there was a conversation with Clr. Boyles to try to work together and see what it would take to get internet service to the hall. There is now a new company with more people working on the lines, and things will move faster. Clr. Boyles said that taxpayers are owed an explanation.

Clr. Parker said that once the project gets past the government money and it can double back, the fibre will already be in place. In the long run, this project will have the most extensive fibre networks in the province.

CERB COLLECTION INFORMATION

Clr. Boyles said that the CERB has been a blunder from day one for many people. Many people appealed their CERB payments, and what is happening now is that appeals are being worked on, but they are taking the money from them. When people go to the MP's office, they don't know who is gathering the money.

It was moved by Clr. Boyles and seconded by Clr. Dewar to write a letter to the federal government asking why money is being taken from people who have appealed the repayment.

Deputy Warden Murray said a resident called regarding the RIM program that was done on MacBeth Road. The residents of MacBeth Road are not very pleased. Deputy Warden Murray informed the resident that the Department of Transportation does this, and it has nothing to do with Council.

Clr. Palmer said he cannot support this letter. Roads are closing in, and trees are coming in over the road. Now that there is a program and reputable forest contractors who come in and do this, there is no easy way. Clr. Palmer said that the Department of Transportation owns 33 metres from the centre line, so it can make the road better.

Clr. Parker said it is ugly but also necessary. A way to do this with less force needs to be found. More tact needs to be developed in how they do this.

It was moved by Deputy Warden Murray and seconded by Clr. Turner to send a letter to the Nova Scotia Minister of Public Works asking for improved communications.
