
## Dispatch change notice

# Keep safety in mind with lithium-ion batteries

There is an emerging trend of house fires being caused by Lithium-Ion batteries. The average modern home contains multiple devices which are powered by Lithium-Ion batteries. Devices such as cell phone, e-bikes, laptops, cordless power tools, vapes/e-cigarettes, toys, and cars are all powered by these types of cells.

The number of Lithium-Ion battery fires is drastically increasing as more household appliances and devices use these types of batteries.

These types of batteries contain large amounts of power in a relatively small cell. They are constructed with two types of materials that if damaged and come in contact with each other cause a violent reaction. These violent reactions can result in fires or explosions. For example, an e-bike, if charged in an enclosed room can result in an explosion significant enough to cause structural damage to a home.

#### Prevention:

If used properly these types of batteries have a very low risk of failure. Several safety precausions can reduce the risk of a Lithium-Ion battery Fire. Do not attempt to extinguish a Lithium-Ion battery fire. Immediately evacuate and call 911.

#### **Safety Tips:**

- Only purchase and use devices that are listed by a qualified testing laboratory (e.g. ULC, CSA).
- Always follow manufacturer instructions.
- Only use the battery that is designed for the device. Do not tamper with the battery packs.
- Only use the charging cord that came with the device.
- Do not charge a device under your pillow, on your bed, or on the couch. This can cause the battery to overheat.



- Do not keep charging the device after it is fully charged.
- Larger battery packs should be charged in a well ventilated area or preferably outside.
- Store batteries away from any thing combustible.
- Do not use batteries that appear to be damaged.

#### Signs a battery is failing:

- Battery has changed shape. (e.g. bulging)
- · Change in colour
- Batteries feel excessively hot
- Odour
- Leaking
- · Making noise

#### What can cause a battery to fail:

- Over charging
- Tampering with battery
- Physical damage
- · Using the incorrect charger

#### How to dispose:

Do not dispose of Lithium-Ion batteries in the trash. (Batteries can be unstable for several days after a failure) Take them to an approved recycling centre. (e.g. Pictou County Solid Waste, Any Town or Municipal Office in Pictou County) If you have any questions or concerns, please contact your local Fire Official at 902-485-2251.

# Property values rise in Nova Scotia

In January property owners throughout Nova Scotia received their 2024 Property Assessment Notices which reflect a market value as of January 1, 2023.

Assessments are determined by Property Valuation Services Corporation (PVSC), the independent, municipally funded, not-for-profit assessment authority for Nova Scotia.

2024 assessments reflect steady upward market activity across the province," says Dave Penny, PVSC's Director of Assessment. "While Halifax continued to have market growth, many rural regions also showed climbing market trends."

The total value of the 2024 Assessment Roll is \$173.6 billion.

"Commercially, business and industrial parks continue to see significant market growth," adds Penny.

2024 property assessments are based on sales and financial data and reflect a market value as of January 1, 2023, and the physical state of properties as of December 1, 2023, including new construction, renovations, demolitions, and impacts from natural disasters.

This year's rate for the provincial government's Capped Assessment Program (CAP) is 3.2 percent. The CAP rate reflects the annual Consumer Price Index (CPI) for Nova Scotia as confirmed by the Province.

The CAP limits the annual increase in taxable assessment for eligible residential properties to no more than the CPI rate for the year. About 68 per cent of residential assessments, 415,576 property accounts, qualify for CAP for 2024.

#### About the PVSC

Property Valuation Services Corporation (PVSC) is an independent, municipally funded, not-for-profit organization that provides property assessment services and information to Nova Scotia's municipalities and property owners.

PVSC is governed by a Board of Directors and led by CEO Kathy Gillis. PVSC's Board includes elected municipal officials, members with municipal experience, independent members, and the CEO of the Nova Scotia Federation of Municipalities (NSFM).

PSVC operates in accordance with the Nova Scotia Assessment Act and internationally accepted standards for mass appraisal from the International Association of Assessing Officers (IAAO).



# Starlink vs. Fibre

Some have questioned why the MOPC is pursuing fibre when options like Starlink are available. It's a reasonable question. Here at the MOPC we view Starlink as a great option for some residents.

The fact of the matter is we have very remote locations in our county and there are some people that may find Starlink is best for them. But as a blanket approach, it is not in the best long-term interests of our residents. Here's why

#### **FINANCIAL ADVANTAGE**

Nova Scotians are well aware of how giving control to just one or a handful of companies plays out.

Consumers pay as companies profit.

Our fibre network is different. It is open-access meaning that companies pay to use our infrastructure. Because multiple companies are using our network, there is built-in competition which keeps the cost lower for residents.

Right now if you want Starlink in Nova Scotia, you'll be paying \$140 a month plus tax. Customers on our fibre network are paying as little as \$34.99 a month.

In addition to the immediate savings residents will see, once the cost of the project is repaid in approximately 20 years, the network will actually generate revenue for the MOPC, which will lessen the burden on taxpayers for years to come. This is an asset that doesn't disappear as soon as you unsubscribe.

#### TECHNOLOGICAL ADVANTAGE

There are also some significant technological advantages to fibre vs. Starlink. Fibre is faster and more consistent in speed.



Our fibre network provides speeds of up to 1 Gbps upload and download. Starlink advertises download speeds of 25 Mbps to 250 Mbps.

#### A BLENDED APPROACH

At the MOPC we believe Elon Musk summed up the situation best in a 2021 interview with Mobile World Live.

"You can think of Starlink as filling in the gaps between 5G and fiber, and really getting into parts of the world that are hardest to reach."

Here in the MOPC we will be able to reach the majority of people with either our fibre network or wireless, but given our geography, 100 percent coverage simply isn't possible.

That's why we encourage residents we aren't able to service to consider options such as Starlink and assistance in installing it available through Build Nova Scotia.

In the end it doesn't come down to wireless OR fibre, or wireless OR Starlink. We believe our residents should have options. Our network delivers that.

# FirstHome network continues to grow

The number of residents connected to the Municipality of Pictou County's wireless network has been steadily growing.

Letters were recently sent to hundreds of eligible households that have been identified as serviceable addresses and more will be notified in the coming weeks.

Those residents are invited to get in touch with MOPC FirstHome staff to sign up for wireless internet. The 25/5 plan is \$49.99 per month (HST extra).

The MOPC has received positive feedback from those who have connected to the service already.

Work is currently underway to complete the Blue Mountain wireless tower which will further extend the network.

On the high-speed fibre side, steady progress has been made in recent months. The service is now available to residents in Lyons Brook, Durham, Mt. Thom, Central West River, Green Hill, Alma, Salt Springs, Loch Broom Loop and along the Sunrise Trail from the Pictou Rotary to Toney River.

Pre-sales will soon be offered for residents from Alma to the New Glasgow border, Graham Lane, Stewart Road, Swamp Road, Sylvester, Hillcrest Trailer Park and Mt. William. Fibre offers the fastest internet with speeds up to 1 Gb available.



### District 7 Clr. offers take on Nova Scotia Power relationship

As most of us are aware Nova Scotia Power Inc. (NSPI) are a privately owned profit driven regulated utility that has a near monopoly on the generation, transmission and distribution of electrical energy within our province. Although we all like to grumble about the cost, compared to the cost of other forms of energy it seems justifiable. As I write this in a warm, well lit home with appliances that work and devices charged, I love them!

However, as I recall the Fiona Fiasco of Sept.-Oct. of 2022 where most of rural Pictonians went one to two weeks plus without power and the several significant interruptions of power during more recent wind events - I hate them! Certainly our climate has changed with more frequent and more severe storm events.

I have been and remain a (sometimes harsh)critic of the reliability of the NSPI power grid. We all have our opinions about brush cutting and grid maintenance issues. We have a vested interest in the reliability of the grid. Now, with the ongoing construction of the MOPC fibre network on the very poles that NSPI owns we



have a further interest in grid reliability. So whether we love them or hate them is a moot point. We want and need the same things.

That being a stronger, more reliable grid to deliver both electrical energy and fibre internet to our communities. We need to sit down together and have an adult conversation. We need to discuss how we can work together for our mutual benefit and at reasonable cost. Let's not fall into the love-hate trap!



## Former East Pictou School demolished



The bulk of the demolition work at the former East Pictou School has been completed in recent months.

The East Pictou school opened in 1952 and was used for a high school and middle school for decades before closing in 2020.

At the conclusion of its use, school ownership was transferred to the Municipality in accordance with the provincial-municipal services agreement.

The MOPC attempted to divest the property in accordance with its standard procedures, but that process resulted in no sale of the property.

Budget Environmental was awarded the tender for the project to demolish the former school. The company was the lowest bidder at \$1.58 million dollars.

There are no current plans for the land, which neighbours Frank H. Academy.



The MOPC gave residents the chance to have a piece of the former East Pictou School by saving some bricks during the demolition process. These bricks were then given to residents in exchange for donations to the food bank or Viola's Place Homeless Shelter.

The Blue Eagles proved their generosity, by donating \$450 plus a large amount of groceries for these two worthy organizations.

# Municipality of the County of Pictou Municipal Grants Requests for Funding

Municipal Grant Applications for the 2024/25 fiscal period are now available from the Municipal Administration Building, 46 Municipal Drive, Pictou, during normal business hours by calling 485-4311 or 752-1530. Funding awarded under this policy is intended for the non-profit sector and charitable organizations that provide community-based programs and services that replace, supplement, or complement a municipal mandate and benefit one or more Council districts or the entire Municipality.

Applications must be returned no later than Thursday, February 29th, to be assessed in preparation for the 2024/25 General Operating Budget. This process assists in ensuring that sufficient funds are budgeted for grant purposes. Consideration of funding requests received after the approval of the General Operating Budget will be limited to the availability of unallocated funds until such time as they are exhausted.

Municipal Grant funding does not replace money available under the Municipality's Recreation Program or Municipal Services Grant Program. Applicants accustomed to receiving funds from both programs are encouraged to contact the Recreation Coordinator or their Municipal Councillor for further information and assistance.

# MUNICIPALITY OF THE COUNTY OF PICTOU NOTICE OF LOW INCOME TAX EXEMPTION



Application forms for a low-income exemption in the 2024/25 tax billing period are now available at the Municipal Administration Building, 46 Municipal Drive, Pictou, N. S., BOK 1HO. Phone 902-485-4311 or 902-752-1530. Applications are also available on our website at <a href="https://www.munpict.ca">www.munpict.ca</a> under the Application and Grant Forms tab.

The exemption is available, upon application, to every person assessed with respect to taxable property in the Municipality of the County of Pictou who is a resident of the County and whose total income from all sources for 2023 was less than \$30,000.

Total income shall be as defined in Section 69(1) of the Municipal Government Act and means a person's total income from all sources for the 2023 calendar year and includes the income of all other members of the same family residing in the same household but does not include a War Veterans allowance or War Veterans pension, HST Refunds, or Child Support Payments. The exemption extends only to the property the applicant occupies as his/her principal residence. Persons applying for the exemption must sign an affidavit regarding their income, and that affidavit must be witnessed by a Commissioner of Oaths for the Province of Nova Scotia or a Municipal Councillor.

Deadline for submissions of applications: March 31, 2024.

Applications received after that date will not be considered.

The beautiful flourishing Scotsburn Community Food Forest is heading into its fifth growing season. This initiative aims to contribute to long term food security through growing and sharing food in regenerative ways and raising awareness through education. In addition to offering free food to our community via the newly built share stand (a collaboration with the Scotsburn Elementary School), a variety of workshops will continue to be offered.

Last winter interested community members came together to create an outdoor skating rink in the park much to the delight of the community.

The rink is up and running again this winter despite some windy weather challenges.

The Fitzpatrick Mountain Trail, maintained by Cape 2 Cape, looks a bit different post Fiona, but is as busy as ever with hikers, snowshoeing and mountain biking.

The entrance to this trail system is located at the ScotsburnTrailhead Park with access to the Trans Canada Trail directly across the road. Such a wonderful combination of ways to be active in a beautiful environment.

The community we serve is important to us. We will continue to keep them top of mind as we move forward. During our last fundraiser, the board decided to donate our profit to the lunch program at the Scotsburn School.

Looking for fun ways to stay physically and mentally active this winter? Try a 100 hours outside sheet, snowshoeing, hiking, sledding, skating, skiing, build a snow fort, making a snow angel or snow man, borrowing a book from your local library, attending trivia, dancing in your kitchen or at a community event, adding food coloring and water to a spray bottle and decorating the snow, yoga at home or with a group, do a puzzle, count how many steps it takes to walk around your house, bake some goodies, start a snowball fight or invite friends and family to a chilly winter bonfire and serve up some hot chocolate.
